# 2020 BBI Rules & Regulations

## **FUTURITY/DERBY ELIGIBILITY**

- 1. Registered foals 4 through 7 years of age from current BBI nominated stallions are eligible, as well as the paid up nominated stallion himself as long as he is of age. To maintain eligibility BBI nomination fees must be paid on an annual basis.
- 2. Open to horses 4 through 7 years of age. Age of horse is determined as of January 1 of calendar year foaled. Futurity horses may not have competed prior to November 15, 2019 of their futurity year.
- 3. If a stallion dies or becomes incapacitated his foals will still be eligible if paid nomination fees are current.
  - 4. Any registered breed of stallion is eligible.
- 5. Rider may compete on more than one nominated horse. BBI horses may enter any or all BBI events in which they are eligible.

#### **OPEN RACE ELIGIBILITY**

- 1. Registered foals of any age from current BBI nominated stallions are eligible, as well as the paid up nominated stallion himself as long as he is of age. To maintain eligibility BBI nomination fees must be paid on an annual basis, or the stallion must have been BBI enrolled the year foal was born.
- 2. Rider may compete on more than one nominated horse. BBI horses may enter any or all BBI events in which they are eligible. Open races pay on the day, a knocked down barrel is a no-time.

#### **NOMINATIONS**

- 1. Nominations will only be accepted by documented owners or documented previous owners of stallions. These names must be on stallions registration certificate. Sire awards will be issued to owner listed on BBI poster & registration papers.
- 2. The 2019 Nomination fee of \$550 is due by February 1, 2019 (discount to charter members). Nomination in U.S. funds only. No refunds.
- 3. A late nomination fee of \$625 will be accepted until June 1, 2019.
- 4. Stallion nominations will be limited to 40 stallions. Charter members (in BBI since the 1999 season) may nominate any stallions they own, even if there are 40 stallions enrolled in BBI. Deceased stallions or geldings with 5 or more registered foals may be nominated.

5. A minimum of 50% of stallion nomination fees will go to the BBI pot. A maximum of \$50 per stallion will be used as administration fees.

## **FUTURITY AND DERBY PAYOUT**

- 1. Payout will be determined on fast times. With payout percentages according to payout sheet.

  1–10 HORSES: 3 monies, 50-30-20

  11–20 HORSES: 4 monies, 40-30-20-10

  21–30 HORSES: 5 monies, 30-25-20-15-10

  Futurity & Derby: paid on average of the two goes of futurity & derby. Not to include short go. Events with derbies will split the pot by percentage of BBI nominated horses in futurity vs. derby. Example: 30

  BBI horses at event, 20 in futurity, 10 in derby = 67% of pot to futurity, 33% to derby.
- 2. Stallion owner payouts will be made at each event. Total of 20% of each event's purse to stud owners. 1st place & 2nd place in Futurity also 1st place & 2nd place in Derby, each getting a 5% check.
- 3. BBI checks will be given out or mailed to competitor only after showing registration papers & verification of the animal is made.

## **OTHER RULES**

- 1. Riders will be responsible for BBI sign up at the events entry office. There is a \$50 registration/handling fee that is charged to the barrel racers. Only horses signed in BEFORE the event starts will be eligible for BBI added money. Riders may be male or female, of any age unless specified by the event. Riders are responsible to enter and make payments with the respective Futurity. A \$20 charge for any/all NSF returned checks. Call 406.240.0986 for entry forms.
- 2. Additional rules may be implemented at BBI discretion. These rules, regulations and requirements pertaining to BBI are subject to change by BBI board, and may be changed and/or amended at any time.
